ANDERSON RESPONDS TO CAIR'S 'ISMLAMOPHOBIC SMEARS' ACCUSATIONS

Overview

At the October 5th board meeting, Supervisor Joel Anderson introduced a board letter that directed the County of San Diego to advocate that the Federal government use frozen Afghanistan assets towards covering the costs of resettlement for refugees. Anderson's colleague, Supervisor Lawson-Remer, added a friendly amendment to create a taskforce to help with the welcoming of these Afghan refugees in San Diego County. Supervisor Anderson asked that any organization that has known ties to terrorism in the Middle East, including the Council on American-Islamic Relations (CAIR), be excluded from participating in the taskforce. Anderson's specific exclusion was not part of the final vote. Days later, CAIR-San Diego sent a letter to the Board of Supervisors seeking reprimand for Supervisor Anderson's 'Islamophobic smears'. Anderson has since responded to CAIR, the Human Relations Commission, and others who have backed these claims.

RECENT ISLAMOPHOBIC COMMENTS MADE BY DISTRICT 2 SUPERVISOR JOEL ANDERSON

The Leon L. Williams San Diego County Human Relations Commission's (HRC) mission is to promote positive human relations, respect, and the integrity of every individual regardless of gender, religion, culture, ethnicity, sexual orientation, age, or citizenship status.

The HRC is concerned, and seriously disturbed with recent Islamophobic comments made by District 2 Supervisor Joel Anderson at the October 5th San Diego County Board of Supervisors meeting and his subsequent statement addressing the comments on October 11th. Additionally, we are shocked and disappointed in the lack of outrage illustrated by the rest of the board regarding these Islamophobic attacks. We find these statements and inaction to be irresponsible, slanderous and in clear opposition of the County's Human Relation Commission's mission and goals. Anderson's regurgitation of vile Islamophobic smears target the nation's leading Muslim civil rights and advocacy organization which has a decades-long history of defending the civil and religious rights of all Americans. These abhorrent statements undermine the work that we as a commission have been brought together to address.

Words have the power to uplift our communities, but they can also be used to drag down our communities with fear and continue to promote unnecessary divisions. Labeling a community group that has a proven track record like CAIR San Diego (CAIR-SD), that has led the way in preparing for refugees as they arrived in San Diego County, should be celebrated. CAIR-SD does not deserve to be slandered with unproven rumors. It is also important to note that CAIR is not listed on any recognized U.S. State or Treasury department terrorist watch list. This community organization has been integral in the assistance of Afghan refugee and resettlement since early August and has been at the forefront of fighting racism and xenophobia, defending civil rights, and supporting civic engagement for all members of the San Diego community for decades.

Supervisor Anderson's irresponsible remarks endanger his own constituents and leaves refugees and other Muslims vulnerable to opportunistic hate groups and individuals who may see his words as a call to act out their hatred. This is the very same community that has experienced serious hate crimes towards refugees and Muslims.

The HRC stands in solidarity with our community and CAIR-SD to fight against bias, bigotry, and racism, regardless of where it comes from and will continue to work to bring our community together. Even if it means holding our elected officials accountable for their statements and actions. The HRC is seeking for the County Board of Supervisors to take a stance against the Islamophobia they are in chambers and in their communities by witnessing their formally censuring Supervisor Anderson unless a public apology and retraction is made. Additionally, we strongly urge for the whole board to schedule a meeting with CAIR-SD to learn the facts about the organization and their work to build-up our community. We urge County Leadership to act quickly to illustrate that Islamophobia has no place in San Diego.

The HRC will agenized an additional discussion on this item at our next regular meeting on November 9th to provide the public a space to share their opinions and to act on further recommendations. RE: Joint Statement on Concern of Islamophobia in San Diego County Board of Supervisors Meeting

Dear San Diego County Board of Supervisors,

We are writing as leading community organizations to express our dismay and disapproval of the vile Islamophobic attacks on the nation's largest Muslim civil rights and advocacy organization who has a decades long history of fighting for the civil rights of all San Diegans and Americans which took place during the October 5, 2021, San Diego County Board of Supervisors Meeting.

Supervisor Anderson, who represents San Diego County's District 2, which is home to a large population of Muslim Americans, regurgitated unfounded and irresponsible Islamophobic attacks on the Council on American Islamic Relations-San Diego (CAIR-SD), a chapter of the nation's largest Muslim civil rights and advocacy organization. These racist and unconscionable smears suggest CAIR's association with terrorist organizations, utilizing overtly Islamophobic stereotypes, put not only the Muslims of San Diego County at greater risk, but also that of CAIR-SD staff.

It is appalling that in the same community in which an Escondido Mosque was attacked with arson, that a County Board Supervisor would employ clear and overtly Islamophobic talking points to exclude the largest Muslim civil rights organization from participating in the Afghan Refugee Resettlement Taskforce, potentially inciting further violence on members of this organization and community. It is further astonishing that the Supervisor believes that using unfounded smears against Muslim organizations can, in any way, lead to constructing a welcoming environment for Afghan refugees and any other new San Diegans who follow the Muslim faith. We were also disappointed in the lack of moral outrage illustrated at the County Board of Supervisors meeting to these Islamophobic attacks which were on full display.

CAIR-SD has been integral in the assistance of Afghan refugee and resettlement since early August, helping families complete Humanitarian Parole applications to bring family members home and convening educational workshops with local immigration attorneys. They've also been at the forefront of fighting racism and xenophobia, defending civil rights, and supporting civic engagement for all members of the San Diego community for decades. Supervisor Anderson's bigoted comments not only ignore this reality while constructing an Islamophobic one of his own but will also undermine these efforts moving forward.

It is for these reasons and countless more that we, the undersigned community organizations, urge Supervisor Anderson to, at minimum, publicly apologize and retract these Islamophobic attacks. We also urge the County Board of Supervisors to take a stance against the Islamophobia they are witnessing in their chambers and in their communities. Excluding or attacking community organizations on baseless claims while simultaneously claiming to assist the communities they serve is disingenuous at best. County Leadership must condemn this speech that divides our marginal communities even further while propagating acts of violence against them.

Dear San Diego County Board of Supervisors,

As a chapter of the nation's largest Muslim civil rights and advocacy organization, the Council on American-Islamic Relations San Diego (CAIR-San-Diego) respectfully requests that the San Diego Board of Supervisors issue an official reprimand for District 2 Supervisor Joel Anderson's Islamophobic smears made against our organization at the board's Oct. 5 meeting.

Supervisor Anderson smeared CAIR during a discussion of our role in assisting Afghan refugees arriving in San Diego County.

We were appalled to hear that supervisor Anderson regurgitated vile Islamophobic smears to target the nation's largest Muslim civil rights and advocacy organization that has a decades-long history of defending the civil and religious rights of all Americans.

Supervisor Anderson needs to apologize for his false and irresponsible comments and the board needs to issue an official reprimand for his Islamophobic actions.

Mr. Anderson's smears will undermine the needed efforts of the Afghan refugee resettlement process and could endanger CAIR San Diego staff.

You may recall bias-motivated attacks on a synagogue and mosque in San Diego County. These incidents are often the result of ignorance, hatred and demonizing rhetoric such as that advanced by Supervisor Anderson."

Dear San Diego County Board of Supervisors,

I write to you as an American, a San Diegan, of Afghan descent, and an American Muslim.

Firstly, I would like to express my gratitude to the entire Board for your support of Afghan evacuees. I know that as a community, we are proud to welcome those who served alongside the U.S. military in Afghanistan. To build a better world together, these Afghans put their lives on the line to advance a common objective of peace and security and they are deserving of their place in America as set forth in the 2008 Defense Authorization Act which established the SIV visa program.

In this letter, I would like to highlight a Supervisor who has made the strongest proposals to support Afghan evacuees, that is Supervisor Joel Anderson. In addition to coming out as the earliest and strongest supporters of vetted Afghans who supported the U.S. military, Supervisor Anderson seems to be the lone Supervisor laboring to preserve the unity in our community that exists to support this important mission.

As an Afghan-American leader in the community, I have spoken with countless Afghans regularly. As Afghan Americans and Muslims, we are firmly behind Joel Anderson. That is why we were frankly disturbed and dismayed by this manufactured political smear campaign against Supervisor Anderson for being "Islamophobic" due to his stating established facts about a single organization that does not represent Afghan-Americans and does not represent the overwhelming majority of Muslims in America, no matter what false internal data might be put forward.

No single organization can or should dare claim to represent "Islam" writ large, such that an attack on an organization is an attack on all Muslims and Islam itself. That is erroneous and intentionally misleading. Further, it is absurd to ascribe that level of religious authority upon oneself. We reject this transparent self-aggrandizement.

Afghan-Americans are led by nobody. American Muslims are led by nobody. We

are free. We are independent as individuals and as families. We are diverse not just in race and ethnicity, but we are diverse in thought. Afghan Americans did not elect any organization to represent us. American Muslims did not elect any organization to represent us. Any organization claiming that an attack on them is an attack on all Muslims should apologize to all American Muslims first, then to Supervisor Anderson for such malice. What is worse, all this has produced is a distraction from the mission at hand: support Afghan evacuees. It has produced division. It has produced tension. As Afghan Americans and American Muslims, we call on all organizations to cease from false representation.

Supervisor Joel Anderson has shown his support over the years to countless Muslims in the community and Afghan-Americans. That is why we urgently call on you to stop amplifying this side show which threatens to disintegrate us all, unnecessarily. We do not believe any elected Supervisor is naive enough to fall for this engineered and baseless smear. But in case any Supervisor believes this political stunt and its absurd slogans, we call on you to see through it, drop it, and get back to the important work of supporting Afghan evacuees.

We have an uncommon moment where all walks of life are together on this important mission to support Afghan evacuees. Please cease from the sideshow, keep this community united, and proceed with your work honorably. Afghan refugees are here and I am noticing a huge lack of commitment to keeping them feeling welcomed and supported. Please do not let us down. We are all watching.

Dear Chair Fletcher,

I am writing regarding correspondence recently submitted to you by the County's Human Relations Commission and a few other organizations alleging that Supervisor Joel Anderson made insensitive comments during the October 5, 2021, Board of Supervisors meeting. Having reviewed the recording of this meeting, it is clear these accusations are patently false.

As someone who personally knows the Supervisor and has worked closely with him to defend the rights of oppressed and persecuted people, I consider Joel Anderson to be a champion of human rights.

By way of background, I have worked for over three decades as a freedom fighter, attempting to replace Islamic republic of Iran with one of a democratic secular <u>rule</u>. As a member of the largest expatriate Iranian community, located in Los Angeles, I continue to assist in the global effort to help those in Iran who face the everyday threat of torture and execution for simply speaking up for human rights.

When it was discovered that billions in assets controlled by the State of California's two largest employee pension funds, — <u>CAIPERS</u> and CaISTRS — were invested in companies conducting business with the country of Iran, Joel Anderson led the effort to divest those investments. He introduced legislation in the State Legislature, Assembly Bill 221, to prohibit these two retirement systems from holding investments in companies affiliated with Iran's defense or nuclear <u>sectors</u>, <u>or</u> doing business with Iran's petroleum or natural gas industries.

It is because of this leadership – standing up against tyrannical regimes with a long-standing history of human rights violations – that I chose to work with Joel Anderson to stand up for the people of Iran by acting against their tyrannical and oppressive regime. For any organization or individual to question or target Joel Anderson's exemplary track record of standing up for human rights for people of all backgrounds and religions is beyond comprehension.

The Muslim community in America and worldwide is incredibly diverse and do not unilaterally share CAIR's politics. Individuals and organizations worldwide are rightfully critical CAIR's history and motives, and that does not make them Islamophobic.

Doctors Against Forced Organ Harvesting November 1, 2021

To Office Joel Anderson County Supervisor, District 2 San Diego County, CA

To whom it may concern:

I am writing as the founder and Executive Director of the NGO Doctors Against Forced Organ Harvesting, DAFOH. DAFOH has been nominated for the Nobel Peace Prize twice, in 2016 and 2017. In 2019, DAFOH has received the Mother Theresa Award for Social Justice. Over the past 15 years, DAFOH has provided the medical community as well as the public with objective findings about forced organ harvesting from living prisoners of conscience in China. Our work contributed to the passing of U.S. House Resolution 343 in 2016. From 2012 to 2018, DAFOH has organized a global petition to the UN High Commissioner for Human Rights against forced organ harvesting collecting over 3 million signatures from over 50 countries and regions.

I am in communication with Mr. Joel Anderson since 2018, then CA State Senator, when he initiated the noble State Joint Resolution 10 (SJR 10), condemning the persecution and forced organ harvesting of Falun Gong practitioners in China. In this context, I learned to appreciate State Senator Anderson as a courageous and committed community leader, who stands firm and undeterred for basic human rights, not looking for a convenient, easy resolve, but going the extra mile to defend the basic rights, in particular from minorities.

In 2018, DAFOH interviewed State Senator Anderson for its quarterly newsletter. Here is, in his own words, what Mr. Anderson stated in March 2018:

"Condemning genocides and standing up for human rights has never been a partisan issue in the past. I believe this episode is demonstrative of the inherent problem of single party rule in a democracy. The voice of the minority is silenced and I have fewer rights than the members of the super majority to have my resolutions heard. I never said anyone has to support it, every legislator is free to vote their conscience, but shouldn't all our constituents have the opportunity to know where we stand? Don't my constituents have a right for the person they elected to be their voice, to have an opportunity to bring my resolution up for a vote?"

State Senator Anderson is a responsible community leader who puts his constituents first, and in this regard, he expresses his views in a transparent and clear form. While doing so, he never forgets the noble and solemn causes and professional standards of his position.

It came to my attention that Supervisor Joel Anderson has been described as "xenophobic". Nothing could be further away from the truth than such a mis-characterization.

By initiating SJR 10, and expressing support of the minority group Falun Gong in China, State Senator Anderson has written into a bill draft that he cares about a foreign group, an action that is per definition the opposite of what one would expect of a person with a xenophobic agenda. In subsequent years, when the world learned more and more about forced organ harvesting from the Moslem Uighurs minority group in China, again, Mr. Anderson followed the emerging news and opposed the practice of forced organ harvesting and maltreatment of the Uighurs in Xinjiang, China.
